# Purusing the Partner and Food Safety Manuals

#### 2025 Partner Manual:

We'd like to focus on the section on **Delivery** (see pages 4-5).

#### Your Role (highlights):

- -Please be patient and flexible as most of our delivery drivers are volunteers.
- -Please allow 30 minutes before and after your scheduled delivery time before calling FMP.

#### FMP Driver Role (highlights):

- -Only drivers unload pallets from the truck.
- -The drivers are the **only** people allowed to be in the truck and on the liftgate/operating the liftgate (please be patient and wait for our drivers to stage your product for your volunteers to move it **safety is our number one concern for all!**)

#### 2025 Food Safety Manual:

We'd like to focus on the section on **Repacking** (see page 7). **This policy was recently updated** FMP defines *repacking* to be any food product that is taken out of its original packaging to create different packaging for the food item. Repacking food is **not recommended** because every time food is handled it increases the risk of contamination and food borne illness.

Repacking is **NOT PERMITTED** or any temperature-controlled foods and TEFAP foods may **NEVER** be repacked.

Dry products may be repacked when absolutely necessary, **BUT**must meet rigorous expectations and follow an extensive list of requirements **BEFORE** repacking can begin. (Contact the Partnership Team at 715-835-9415 ext. 5 if interested in beginning conversations about the process.

Please also make sure they are completely empty, including onion skins. Banana boxes with residual "stuff" in them make another clean-up step for us here at FMP. We reuse these boxes to pack food in. Thank you for your help with this!

\*Please see the picture for directions on how to combine 2 banana boxes together into a cube (the **tops** go on the top and bottom and the **bottoms** go in the middle).
